ASSISTANT OR ASSOCIATE PROFESSOR - INSECT PATHOLOGIST. The Department of Entomology and Plant Pathology at The University of Tennessee at Knoxville is seeking candidates for a 12-month, tenure-track position in insect pathology.

The successful candidate will establish a sustainable, dynamic, cooperative research program in insect pathology, concentrating on the management of invasive insects with a strong applied component. The successful candidate will advise graduate students and contribute to the overall research, teaching, and outreach programs of the Department. This position will be a 100% research appointment; however, graduate student training is expected. Candidates must have a Ph.D. or equivalent in Entomology or related zoological science at the time of the appointment with graduate or postdoctoral experience in insect pathology, and will have demonstrated the ability to develop a sustainable, grant-driven research program that results in publication of refereed, scientific publications. Experience in the application of insect pathology to applied pest problems and demonstrated experience and interest in invasive insects in North American ecosystems is required. The successful candidate will assume an active role in the management of the Lindsay Young Beneficial Insects Laboratory. Excellent verbal and written communication skills are required.
